

**MACARTHUR CENTRAL SHOPPING CENTRE “VOTE FOR A CHANCE
TO WIN A \$500 PREZZEE GIFT CARD” PROMOTION
TERMS AND CONDITIONS**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this **“VOTE FOR A CHANCE TO WIN A \$500 PREZZEE GIFT CARD”** Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions.
2. The promoter is **MacArthur Central Shopping Centre Pty Ltd ACN 119 813 795** of Centre Management, 255 Queen Street, Brisbane QLD, 4000 (**“Promoter”**).

ELIGIBILITY

3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
4. 5. Promotion commences at 7.00am on Tuesday 4 August 2026 and closes at 9.00pm on Monday 31 August 2026 (**“Promotional Period”**). All times throughout the Terms and Conditions will be based on Brisbane local time.

LIMITS ON ENTRY

7. Limit of one (1) entry permitted per eligible person, per the entry period for the one prize draw.

DRAW DETAILS

8. The prize draw will take place at the Participating Centre at 11.00am on Thursday 3 September 2026. The Promoter reserves the right to draw reserves in case of an invalid entry or invalid entrant.
9. The provisional winner(s) will be notified in writing within two (2) business days of the draw. A provisional winner will only be deemed a winner once verified by the Promoter.

PRIZES

10. The first one (1) valid entry randomly, from all valid entries received will win a \$500 Prezzy Gift Card valued at AUD\$500.00.
