

MACARTHUR CENTRAL WIN LUNCH FOR YOU AND A FRIEND 2.0 PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and prize(s) form part of these Terms and Conditions. Participation in this **February 2020 Win Lunch for You and a Friend 2.0 Promotion (Promotion)** is deemed acceptance of these Terms and Conditions.

ELIGIBILITY
