

**MACARTHUR CENTRAL SHOPPING CENTRE “WIN A NINTENDO
SWITCH CONSOLE OLED” PROMOTION
TERMS AND CONDITIONS**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “**WIN A NINTENDO SWITCH CONSOLE OLED**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions.
2. The promoter is **MacArthur Central Shopping Centre Pty Ltd ACN 119 813 795** of Centre Management, 255 Queen Street, Brisbane QLD, 4000 (“**Promoter**”).

ELIGIBILITY

3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. LIMITS ON ENTRY
