

**MACARTHUR CENTRAL SHOPPING CENTRE “VOTE FOR A CHANCE  
TO WIN A \$500 JB HI-FI GIFT CARD” PROMOTION  
TERMS AND CONDITIONS**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this **“VOTE FOR A CHANCE TO WIN A \$500 JB HI-FI GIFT CARD”** Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions.
2. The promoter is **MacArthur Central Shopping Centre Pty Ltd ACN 119 813 795** of Centre Management, 255 Queen Street, Brisbane QLD, 4000.(**“Promoter”**).

**ELIGIBILITY**

3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.

**LIMITS ON ENTRY**

**DRAW DETAILS**
