

**MACARTHUR CENTRAL SHOPPING CENTRE “BEATS STUDIO 3  
WIRELESS NOISE CANCELLING OVER-EAR HEADPHONES FROM JB  
HI-FI” PROMOTION  
TERMS AND CONDITIONS**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this **“BEATS STUDIO 3 WIRELESS NOISE CANCELLING OVER-EAR HEADPHONES FROM JB HI-FI”** Promotion (**“Promotion”**) is deemed acceptance of these Terms and Conditions.
2. The promoter is **MacArthur Central Shopping Centre Pty Ltd ACN 119 813 795** of Centre Management, 255 Queen Street, Brisbane QLD, 4000.(**“Promoter”**).

**ELIGIBILITY**

3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions.   - a. Opt-In to receive Marketing material from MacArthur Central Shopping Centre
  - b. Accept the competition and subscriptions terms and conditions.
  - c. Submit the competition entry.

**LIMITS ON ENTRY**
