

**MACARTHUR CENTRAL SHOPPING CENTRE “WIN A STUDENT
KITCHEN ESSENTIAL PACK” PROMOTION
TERMS AND CONDITIONS**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “**WIN A STUDENT KITCHEN ESSENTIAL PACK**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions.
2. The promoter is **MacArthur Central Shopping Centre Pty Ltd ACN 119 813 795** of Centre Management, 255 Queen Street, Brisbane QLD, 4000 (“**Promoter**”).

ELIGIBILITY
