### TERMS AND CONDITIONS

1. Instructions on how to claim and the reward(s) form part of these Terms and Conditions. Participation in this offer is deemed acceptance of these Terms and Conditions. Offer not valid in conjunction with any other offer.
2. The Promoter is **MacArthur Central Shopping Centre Pty Limited** (ABN 99 598 409 154) of 255 Queen Street, Brisbane QLD 4000.

### **ELIGIBILITY**

3. Claims are only open to **Australian / New Zealand** residents **aged 18 years or over**.
4. Claimants under 18 years old must have parental/guardian approval to claim and further, the parent/guardian of the claimant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor submitting a claim in this offer.
5. ### **HOW TO CLAIM**

Alternatively, claimants can download the MacArthur Central App (“App”) to their smart mobile device. Once downloaded, claimants must then follow the prompts to create an account by providing their full name, email address, contact phone number, suburb of residence, DOB and a password.

## **LIMITS ON THE NUMBER OF CLAIMS**

8. Only one (1) reward is permitted per person.

## **REWARDS**

## **GENERAL**

13. The Promoter's decision is final and no correspondence will be entered into.
