

MACARTHUR CENTRAL SHOPPING CENTRE “WIN 1 of 3 BIG W GIFT CARD” PROMOTION TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “**WIN 1 of 3 BIG W GIFT CARD**” Promotion (“**Promotion**”) is deemed acceptance of these Terms and Conditions.
2. The promoter is **MacArthur Central Shopping Centre Pty Ltd ACN 119 813 795** of Centre Management, 255 Queen Street, Brisbane QLD, 4000. (“**Promoter**”).

ELIGIBILITY

3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
4. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers in MacArthur Central Shopping Centre (“**Participating Centre**”) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

5. Promotion commences at 7.00am on Tuesday 27 January 2026 and closes at 9.00pm on Saturday 28 February 2026 (“**Promotional Period**”). All times throughout the Terms and Conditions will be based on Brisbane local time.

LIMITS ON ENTRY

7. Limit of one (1) entry permitted per eligible person, per the entry period for the one prize draw.

DRAW DETAILS

8. The prize draw will take place at the Participating Centre at 11.00am on Tuesday 3rd March 2026.

The Promoter reserves the right to draw reserves in case of an invalid entry or invalid entrant.

9. The provisional winner(s) will be notified in writing within two (2) business days of the draw. A provisional winner will only be deemed a winner once verified by the Promoter.

PRIZES

GENERAL

13. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including their respective officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (g) use of a prize.
