

MACARTHUR CENTRAL SHOPPING CENTRE “SHOP. SCAN. WIN.” PROMOTION TERMS AND CONDITIONS

TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this “Shop. Scan. Win.” Promotion (**Promotion**) is deemed acceptance of these Terms and Conditions.
2. The promoter is MacArthur Central Shopping Centre Pty Ltd ACN 119 813 795 of Centre Management, 255 Queen Street, Brisbane QLD, 4000. (“Promoter”).

ELIGIBILITY

3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
4. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers in MacArthur Central Shopping Centre (“Participating Centre”) or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

6. Promotion commences at **7:00am** on **Thursday 4 June 2026** and ends at **9:00pm** on **Sunday 19 July 2026 (Promotion Period)**. All times throughout the Terms and Conditions will be based on Brisbane local time unless otherwise advised.

HOW TO ENTER

7. To enter, eligible individuals must, during the Promotion Period,
 - Spend \$12 or more in a single transaction at any participating food and beverage retailer, including Bapboi Express, Hanaichi, Harol’s Espresso, KFC, Sharetea, Supreme Carvery, Wara Sushi (each as **Qualifying Transaction**); or
 - Spend \$50 or more in a single transaction at any participating Specialty Store (excluding any costs associated with prescription, lotto, or tobacco), including Longines, Paspaley, Tag Heuer, Australian Skin Clinics, Complete Skin & Beauty, Doll Face Brow & Make Up Studio, Joel’s Barber Shop, Liquid Nail Bar, Luxe Nail Salon, Bailey Nelson, Priceline Pharmacy, The Health Food Shop, Caseway, CeX, AusXchange and Mister Minit (each as **Qualifying Transaction**); or
 - Spend \$100 or more in a single transaction at Big W, Woolworths, or JB HI-FI (each as **Qualifying Transaction**)within MacArthur Central Shopping Centre (**Participating Centre**) where the customer will receive **one** unique entry code. It is the entrant’s responsibility to request a unique entry code if a unique entry code is not provided at the time of completing a Qualifying Transaction.
8. Entrants must then during the Promotion Period **visit www.macarthurcentral.com.au** and fully and correctly complete their entry in accordance with the instructions provided, including the unique entry code.

LIMITS ON ENTRY

10. Multiple entries are permitted per person, subject to the following: (a) only one entry permitted per Qualifying Transaction; (b) each entry must be submitted separately and in accordance with entry requirements; (c) only one unique entry code per entry is permitted; (d) the same unique entry code cannot be used more than once; and (e) unrecognised codes will be deemed invalid.

DRAW DETAILS

11. The draw will take place at the Participating Centre at MacArthur Central Shopping Centre, 255 Queen Street Brisbane, QLD 4000, at **11.00am on Monday 20 July 2026**. The Promoter reserves the right to draw reserves in case of an invalid entry or invalid entrant.
12. The provisional prize winners will be notified by telephone and in writing within two (2) business days of the draw. A provisional winner will only be deemed a winner once verified by the Promoter.
13. The winner's name and postcode will be published on the Promoter's website from Wednesday the 22nd of July 2026 (macarthurcentral.com.au) until Wednesday 19 August 2026.
14. Entrants can only enter in their own name and use their own email address. The Promoter reserves the right to request a provisional winner provide proof of identity, proof of residency, and/or proof of entry validity. Proof of identification, residency and entry considered suitable for verification is at the discretion of the Promoter. The Promoter reserves the right to validate and check the authenticity of any prize claim or entry before awarding the prize.

PRIZES
